### 2-DEFINITION AND GENERAL CONDITIONS

A. This contract has been signed between the organizer and the competitor whose identity information is in this contract under the following conditions.

B. With this contract, under the conditions set out below, the competitor, will pay the fee and participate in the organization arranged by the organizer

C. The mentioned organization is the first private competition in Turkey to be awarded. The organization will be held in Antalya region; will be open to all world fitness and bodybuilders and bodybuilding teams.

D. Competitors will take place on stage according to their weight categories and compete for awards like medals and cups

E. International Anatolian Cup, will take place at Antalya Sports Hall with a capacity of ten thousand people. The competition will be held between 18/10/2024 ~ 20/10/2024.

F. The open address of the location where the competition will be held is "Meltem Mahallesi Sakıp Sabancı Bulvarı No: 6 Muratpaşa Antalya (Antalya Sports Hall).

G. The total prize to be distributed in the competition is 600,000 TL. (Six Hundred Thousand Turkish Lira). The distribution will be determined by the organizer.

H. The Organizer has the right to dismiss any competitor without giving any reason.

I. Competitors who behave disrespectful, use rude language, who are abusive and slang to other competitors, guests and organizers during the organization-and whoever come to the competition area with alcohol will be dismissed and not paid back any fees.

J. The organizer is not responsible for lost items. If anything is lost, the competitor must immediately inform the organizer or the organization staff.

K. The organization has the right to end or postpone any organization. The competitor cannot claim any fee or compensation unless the organizer completely terminates his activities. In such cases, the re-operation of the organization is expected by the competitor. The Organizer undertakes in advance that this period will be kept at reasonable levels.

L. The competitor is responsible for the damage and damage that will be caused by his fault and negligence.

M. Competitors declare at the end of this contract that their health conditions are suitable for the activities of the organization. It is up to them to check whether they have had their medical check-ups or whether they are living in accordance with the medical advice given by their health counselor and no claim can be made against the organizer in these matters.

N. From the moment the competitor signs the contract; He/she accepts, declares and undertakes that his/her health status is suitable for performing the activities of the organization, that he/she does not have any discomfort, and that participating in such exercises will not harm his/her health and physical condition.

O. Competitors, who are careless and neglected will be responsible for lost and damaged items that belong to other competitors or any item that is at the organization area.

P. If the competitor commits criminal acts and is not respectful to other competitors and organization staff, has violence acts, humiliates others or doesn't obey the rules, he/she can be dismissed by the organizers temporarily or permanently and will not be paid the competition fee back.

## **3-ACCOMMODATION**

A. The competitor will be able to stay in the hotels agreed in the website by making reservations individually. The organization will not be responsible for delays caused by not being able to find a place.

B. The competitor will pay the price for the reservation himself. The organization will not be involved.

C. Since the competitor will represent the organization in the agreed hotels, he/she should obey the hotel's rules.

D. The competitor must personally cover the expenses incurred during the accommodation.

E. If the competitor damages the property or commodities of the hotel during or after painting, he/she has to pay.

## 4-COMPETITION AREA RULES

A. The competitor is obliged to comply with all aspects of the organization managers and organization team's instructions as soon as he sets foot on the the organization area including the weighing day. if not he/she will not be obeying the aspects of the contract he signed.

B. The competitor is responsible to keep the number and weight given to him.

C. The competitor accepts the weighing results of the officials in the weighing area in advance and without objection. However, if the competitor sees that he has not reached the desired goal in the weighing scale and declares it himself, a second right is given to him. The competitor is given time to reach the desired volume or form until the end of the scale.

D. The competitor must fill in and sign the pre-registration form to be distributed before the weighing and give the form to the staff and line up.

E The competitor only if he/ she has a badge or wristband will be able to enter the competition area. If the competitor removes or loses his Badge or Wristband, a new one from the organization will only be given by paying a fee for it.

F. The competitors assistants or coaches may be present in the first part of the backstage, which is two parts. If the they want to go into the second part of the backstage they have to pay extra.

G. The competitor accepts in advance the rules of the supervisor about all kinds of materials and behaviors at backstage.

H. During the competition if the competitor at backstage does not pay attention to the podium calls and misses the stage the backstage supervisor or the organization staff will not be responsible.

I. The competitor will prepare a USB disk containing 60 seconds of posing music and write his name on the digital material. There should be only one song in it but nothing else. In the posing music there should be no slang and vulgar expressions.

## 5-PRESENTATION RULES

A. IFBB's general and specific Rules will apply to the Competition.

B. The determined categories will be present at the backstage area and listen to the commands of the backstage Supervisor.

C. Competitors on the podium must obey and apply the voice commands of the podium supervisor.

D. Following the instructions of the podium supervisor directly affects the scoring.

E. The competitor who is on stage will not be in any kind of attitude or behavior that will impair the competency of the Competition.

A. The competitor, in accordance with the KVKK No. 6698, of his personal or private data; to be obtained, recorded, stored, modified, updated, periodically checked, rearranged, classified, kept for the period required for the purpose for which they are processed or for the period stipulated in the relevant law, in case of legal or need-based actual requirements, with public institutions and organizations that the organizer works with or for which it is legally liable, or in case of de facto transfer to third parties, organizations or institutions, including legal partnerships or institutions residing in Turkey or abroad; It gives its consent, with its explicit consent, in an informed and enlightened manner, without any hesitation about the subject. ## 9-CONTRACT CANCELLATION AND REFUND

A. The competitor must notify the organizer of the cancellation request in writing . If the it is not made in writing it will not be valid and will not have legal consequences.

B. The competitor can cancel his participation within 3 days from the day the contract is signed, without giving any reason, by notifying the organizer in writing. If a financial transaction has been carried out for the competitor during this period, this price will be deducted.

C. If the fee is paid by credit card, no commission, tax, etc. will be charged from the amount to be refunded. 20% deduction will be made for other expenses. Payments made by credit card will be refunded to the same credit card.
